Amendments to the Bye Laws**

8 A	<p>Officer's Subscription</p> <p>(a) Regional Grand Chapter Officers on conferring the first Past or Active Rank shall pay a subscription of Rs.500/- as life members subscription. (Non Refundable)</p> <p>All other Past Regional Grand Chapter Officers and all other Past & Reigning First Principals of daughter Chapters shall pay a subscription of Rs.50/- each year. The Annual subscription of Rs.50/- shall be recovered (i) through the Chapter of which the officer is a subscribing member and is considered for Regional Ranks; (ii) if not holding Regional Rank through the Chapter in which the officer was installed as First Principal, (iii) And if the officer ceases to be a subscribing member of the Chapter in which he was installed as First Principal, then through the Chapter opted by him. The Annual subscription shall be remitted by the Chapter along with the dues payable in the Yearly Return for the period ending 31st December every year.</p> <p>(b) Reigning 1st Principal, 2nd Principal and 3rd Principal of daughter Chapters shall pay Rs.200/- as yearly subscription. This fee shall be paid by the daughter chapter along with installation return.</p>
