Dear Sir & RW/VW/W. Bro /M/E. Comp. / Scribes

As per the Points of Procedure and Protocol for guidance regarding Amendments to Bye-Laws points (a) & (b):

- a) Notice of motion for addition/deletion/alteration to any of the provisions of the Bye-Laws of the Lodge must be given in a regular meeting of the Lodge.
- b) Immediately on receipt of such a Notice the Worshipful Master should convene a meeting of the Lodge Committee to consider the said notice and direct the Secretary to place it as an item on the agenda for the next regular meeting of the Lodge.

**The Revised Point (b) should read as:**

Immediately on receipt of such a Notice the Worshipful Master should convene a meeting of the Lodge Committee to consider the said notice and direct the Secretary to place it as an item on the agenda for the next regular meeting of the Lodge. However if the motion is moved in the open Lodge after the approval of the Lodge Committee, the amendment need not go to the Lodge Committee again.
